The rest I can prove by either witness testimony or collecting further evidence via production of evidence filings. If I do not receive the vehicle within three (3) days (72 hours) starting from the minute an hour you received this, I will proceed with: Filing a formal wage claim Filing civil litigation Notifying all applicable authorities listed above At that point, the choice is yours. Do the right thing — for your sake. I will even give you my paypal information so that I can buy a vehicle myself. However, if you low ball me or under pay me, I will send the money right back. My wife lost most of her stuff, and I lost some of my stuff. You have had my paypal information since July 2nd before we lost most of our stuff. I am running out of diapers, and what little bit of food I have for them. That's not including what you did while I was working for you. I am in the very process of preparing legal documents for the court. I contacted Mark and recorded our conversations. He admits to spilling the diesel, serving raw undercooked chicken strips, not having a food handler's card, working under the table, and that the door to the storage rv that housed employees was already broken. He also admits that he started serving food not long after you guys arrived at Sand Mountain, which is before the trailer had ever been inspected and approved. The official inspection and approval happened on or around April 17. You guys started serving food in late March. Plus, he further admitted that he knew you were hiding your cash earned from sales. However, I am not going to tell you everything that we talked about or that I know. I just want everything that I am legally owed and/or entitled to, which includes money for damages I incurred because of your acts.
